Dr. Winegar's Cancellation Policy

We want to make your experience here as easy and as timely as possible. We need your help in doing so. We understand there are times when you must miss an appointment due to emergencies. However, our cancellation policy dictates that an appointment must be cancelled at least 24 hours in advance. If you are unable to cancel within 24 hours prior to your scheduled appointment, or if you are **greater than 20 minutes late** to your scheduled appointment, you will **be charged fifty dollars (\$50)** for a cancellation/no show/late fee. You may not be able to be seen if you are greater than 20 minutes late, depending on how busy the office is. This fee will NOT be covered by your insurance company. This policy will assist keeping our schedules as efficient as possible to get our patients in to see the doctor in a timely manner. Thank you for your cooperation with this policy.

____ Arriving late to scheduled appointment greater than 20 minutes - \$50 fee and you may not be able to see the doctor and may need to reschedule.

Dr. Winegar's Pain Medication Policy

Please carefully read the policy below and initial to the left of each paragraph.

_____ Pain medication prescriptions will ONLY be dispensed to patients scheduled for surgery, for post-operative treatment, or after an acute fracture. For these patients, the pain medication will be closely monitored and discontinued as soon as possible. No pain medication will be able to be prescribed after 2 months. If you feel you need pain medications after this time, you will be referred to a pain clinic or a physician specially trained to treat chronic pain.

_____ Available days to pick up prescriptions are Tuesdays and Thursdays by 5:00pm and no later. Dr. Winegar **must be in the office** to sign the prescription. These can ONLY be picked up in our Salt Lake City office, and cannot be faxed due to regulations on controlled medication substances. NO ONE IS AVAILABLE Friday through Sunday to refill your medication. Please plan accordingly.

_____ Pain medication can only be prescribed by one doctor at a time. Violating this could be grounds for a physician to lose their practicing license. You are required to notify us if you are receiving pain medication from another physician.

_____ If you are already taking prescribed pain medications for a prior issue such as chronic pain or a prior injury you will need to contact your pain management provider to receive additional medication. We CANNOT prescribe pain medication to you if another provider already is.

_____ If you have a history or current substance abuse issue we will not prescribe you pain medications, however we are able to refer you to a pain management physician who can help manage pain.

_____ Pain medicine will be prescribed at our discretion. Signing this document does not guarantee you a pain medication prescription.
